ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the Port of Grays Harbor from January 1, 2013 through December 31, 2013.

We evaluated internal controls and performed audit procedures on the activities of the Port. We also determined whether the Port complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Open public meetings
- General revenue and expenses
- Annual report
- Key system controls

- Procurement public works
- Lease agreements
- Cash receipting
- State grants

RESULTS

In the areas we examined, the Port's internal controls were adequate to safeguard public assets. The Port also complied with state laws and regulations and its own policies and procedures in the areas we examined.

ABOUT THE PORT

The Port of Grays Harbor was incorporated in 1911 to serve the citizens of Grays Harbor County. The Port provides a marine terminal, marina, airport and industrial park facilities.

An elected, three-member Board of Commissioners governs the Port. The Board appoints an Executive Director and a Director of Finance and Administration to oversee the District's daily operations as well as its approximately 46 full-time and 27 part-time employees. The Port generated operating revenue of over \$30 million in 2013, financed primarily through user fees.
