ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the City of Olympia from January 1, 2013 through December 31, 2013.

We evaluated internal controls and performed audit procedures on the activities of the City. We also determined whether the City complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Third party cash receipting
- Financial condition
- Utilities
- Procurement public works projects

ABOUT THE CITY

The City of Olympia is located in Thurston County and is the county seat and the Washington State Capital. The City provides its 48,480 citizens a full range of municipal services including public safety (police, fire, court and jail), sanitation, utility (water, sewer and stormwater), streets, parks and recreation, community planning and development, zoning and general administrative services.

The City is governed by a council-manager form of government with seven elected Council Members including the Mayor who is elected to position one of the Council. The Council appoints a Manager to oversee the City's daily operations as well as its 546 full-time employees. In fiscal year 2013, the City operated on a general fund budget of \$71.3 million.
