## **Audit Summary**

### City of Walla Walla Housing Authority Walla Walla County August 18, 2014

#### ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the City of Walla Walla Housing Authority from January 1, 2012 through December 31, 2013.

We evaluated internal controls and performed audit procedures on the activities of the Housing Authority. We also determined whether the Housing Authority complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Credit cards
- Tenant receivable write-off

- Payments/expenditures
- Financial condition

#### RESULTS

In the areas we examined, the Housing Authority's internal controls were adequate to safeguard public assets. The Housing Authority also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### ABOUT THE HOUSING AUTHORITY

The City of Walla Walla Housing Authority was established in 1973 with the mission to provide decent, safe, sanitary and affordable housing to low-income families including elderly, disabled people and homeless veterans. The Housing Authority owns and manages 198 multi-family units, provides property management for 158 units and administers a Housing Choice Voucher program and Tenant Based Rental Assistance program. The Housing Authority provides housing assistance to more than 1,057 families annually in Walla Walla and Columbia counties.

A six-member Board of Commissioners, appointed by the Mayor of the city of Walla Walla, governs the Housing Authority. The Board is responsible for establishing the vision, goals and policies of the Housing Authority. In addition, the Board appoints an Executive Director to oversee the Housing Authority's daily operations as well as its approximately 29 employees. The Housing Authority is primarily funded with grants provided by the U.S. Department of Housing and Urban Development (HUD) totaling approximately \$5.5 million.
