#### AUDIT SUMMARY

#### **Results in brief**

In most areas we audited, Housing Authority operations complied with applicable requirements and provided adequate safeguarding of public resources. The Housing Authority also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to the Housing Authority management in a letter dated August 19, 2014 related to the tax credit partnership. We appreciate the Housing Authority's commitment to resolving those matters.

#### About the audit

This report contains the results of our independent accountability audit of the Housing Authority of Grays Harbor County from January 1, 2012 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Housing Authority's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open public meeting minutes
- Key system controls
- Tax credit partnership

- Tenant rental revenue
- Disbursements
- Petty cash
- Financial condition/restricted funds

#### **RELATED REPORTS**

#### Financial

Our opinion on the Housing Authority's financial statements and compliance with federal grant program requirements is provided in a separate report, which includes the Housing Authority's financial statements.

#### Federal grant programs

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the Housing Authority's major federal programs, which are listed in the Federal Summary section of the financial statement and single audit report.

#### **INFORMATION ABOUT THE HOUSING AUTHORITY**

The Housing Authority of Grays Harbor County was established in 1951. The Housing Authority operates programs primarily funded by the Department of Housing and Urban Development (HUD) to provide rental subsidies and improve the physical condition of the existing public housing projects. These programs serve eligible low-income, elderly and disabled people to meet their needs for safe and sanitary housing. In October 2002, the Housing Authority acquired a 20-unit apartment complex in Aberdeen. In previous years, the Housing Authority acquired an 18-unit apartment complex in Ocean Shores and a 59-unit apartment complex in Housing in Housing program, the Section 8 Housing Choice Voucher program, the Public Housing Capital Fund program and the Section 8 Housing Assistance Payments program.

The Housing Authority is governed by a five-member Board of Commissioners appointed by Grays Harbor County. In 2013 the Housing Authority employed 24 people and operated on a \$3.5 million annual budget.
