## AUDIT SUMMARY

### Results in brief

In the areas we audited, Town operations complied with applicable requirements and provided adequate safeguarding of public resources. The Town also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the Town of Oakesdale from January 1, 2012 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Town's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Cash receipting
- Payroll/personnel
- Payments/expenditures
- Compliance with grant requirements

## RELATED REPORTS

### **Federal grant programs**

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the Town's major federal program, which is listed in the Federal Summary section of the federal program audit report.

## INFORMATION ABOUT THE TOWN

The Town of Oakesdale, incorporated in 1888, serves approximately 425 citizens in Whitman County. The Town has two full-time employees who provide police, water, sewer, street and general administrative services.

An elected, five-member Council and an independently elected Mayor govern the Town. The Town had expenditures of approximately \$405,000 and \$1,674,300 for fiscal years 2012 and 2013, respectively. The increase in expenditures for 2013 was due to street and bridge projects.
