## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the Walla Walla County Conservation District from January 1, 2012 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Conservation Reserve Enhancement Program expense validity
- Payroll valuation
- Compliance with procurement requirements for purchases and vendors

## RELATED REPORTS

### **Financial**

Our opinion on the District's financial statements and compliance with federal grant program requirements is provided in a separate report, which includes the District's financial statements.

### **Federal grant programs**

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the District's major federal programs, which are listed in the Federal Summary section of the financial statement and single audit report.

## INFORMATION ABOUT THE DISTRICT

The Walla Walla County Conservation District was established in December 1961. The District provides administrative and operational assistance to the public in resource conservation projects. Oversight responsibility for the District is vested with a five-member Board of Supervisors, three independently elected and two appointed. Fiscal responsibility including budget authority, the power to set fees and issue debt also rests with the Board.

The majority of the District's revenue is from state, local and federal grants, which reimburse almost all of the District's expenses each year. In fiscal year 2012, the District had revenue of \$3.3 million, 98 percent of which was from grant funding. In fiscal year 2013, the District had revenue of \$6.4 million, 98 percent of which was from grant funding.
