## AUDIT SUMMARY

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the Lynden Transportation Benefit District from January 1, 2013 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Formation
- Open Public Meetings Act

- Submission of annual report
- Disbursements

### INFORMATION ABOUT THE DISTRICT

The Lynden Transportation Benefit District is a separate legal entity created by the city of Lynden in July 2012, under RCW 36.73, for the purpose of financing the city's transportation related activities. The City Council serves as the governing board of the District.

The District's only activity is to collect a 2 percent sales and use tax. The tax is collected by the city on the District's behalf and is currently being used for the Bradley and Line Road Improvement project and the Chip Sealing and Repainting project. The District had operating expenditures of \$262,850 in 2013.
