## AUDIT SUMMARY

### Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the City of Redmond from January 1, 2013 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Payroll disbursements
- Compensation of public officials
- Self-insurance programs
- Credit card purchases
- Stormwater utility fees
- General disbursements
- Business license cash receipts
- Financial condition
- Travel expenditures
- Sole source procurement
- Nonprofit service contracts
- Conflict of interest
- Court cash receipts

### **Financial**

Our opinion on the City's financial statements and compliance with federal grant program requirements is provided in a separate report, which includes the City's financial statements.

### **Federal grant programs**

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the City's major federal program, which is listed in the Federal Summary section of the financial statement and single audit report.

## INFORMATION ABOUT THE CITY

The City of Redmond serves approximately 55,840 residents within King County. The City lies east of Lake Washington contiguous to the cities of Kirkland, Bellevue and Woodinville. The City provides services including fire, police, water/sewer/storm utilities, public works, community development and parks and recreation.

An elected, seven-member Council governs the City. The Council appoints management to oversee the City's daily operations and has approximately 610 full- and part-time employees. For the 2013-2014 biennium, the City operates on a budget of approximately \$694 million.
