#### AUDIT SUMMARY

#### **Results in brief**

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the City of Shoreline from January 1, 2013 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash receipting
- Payroll
- Budget amendments

- Open public meetings
- Cost allocation
- Financial condition

#### **RELATED REPORTS**

#### Financial

Our opinion on the City's financial statements and compliance with federal grant program requirements is provided in a separate report, which includes the City's financial statements.

#### Federal grant programs

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the City's major federal programs, which are listed in the Federal Summary section of the financial statement and single audit report.

#### **INFORMATION ABOUT THE CITY**

The City of Shoreline, incorporated in November 1995, serves a population of 53,670 citizens in King County. The City provides community and economic development, public works, and parks and recreational services. It contracts with King County for police services. Separate agencies provide fire protection and water services.

An elected, seven-member Council governs the City. The Council selects one of its members to serve as Mayor for a two-year term. The Council appoints a Manager to oversee the City's daily operations as well as its 139 full-time employees. For fiscal year 2013, the City operated on an annual budget of approximately \$74 million.
