## AUDIT SUMMARY

### Results in brief

In the areas we audited, Airport operations complied with applicable requirements and provided adequate safeguarding of public resources. The Airport also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the Pangborn Memorial Airport from January 1, 2012 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Port's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the area examined represented the highest risk of fraud, loss, abuse, or noncompliance. The following area was examined during this audit period:

## INFORMATION ABOUT THE AIRPORT

Pangborn Memorial Airport is located in Douglas County and offers air transportation service to Wenatchee, East Wenatchee and the surrounding area. A three-member Board of Commissioners, comprised of board members of the Port of Chelan County, governs the Airport. The Board appoints a Manager to oversee the Airport's daily operations as well as its 10 full-time employees.

The Airport receives operating revenue through user fees and a Joint Operating Agreement with the ports of Chelan and Douglas counties. For fiscal years 2012 and 2013, the Airport operated on an annual budget of approximately \$2.8 million.
