## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the King County Ferry District from January 1, 2013 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Accountability for assets
- Open public meeting minutes
- Payments/expenditures
- Compliance with inter-local agreements

## RELATED REPORTS

### **Financial**

Our opinion on the District's financial statements and compliance with federal grant program requirements is provided in a separate report, which includes the District's financial statements.

### **Federal grant programs**

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the District's major federal programs, which are listed in the Federal Summary section of the financial statement and single audit report.

## INFORMATION ABOUT THE DISTRICT

The King County Ferry District was created on April 30, 2007, by the King County Council under chapter 36.54 RCW. It provides passenger-only ferry service. It operates routes from Vashon Island and West Seattle to downtown Seattle. By statute, the King County Council serves as the District's Board of Supervisors. The District contracts out the management of daily operations to the King County Marine Division by inter-local agreement with King County.

Although a component unit of King County, the District is a separate legal entity with its own taxing authority. It levies 1/3 of one cent property tax per \$1,000 assessed value to pay for operations. In addition to the tax levy, the District receives revenue from passenger fares and state grants.
