## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of Public Utility District No. 1 of Kitsap County from January 1, 2012 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Credit cards
- Financial condition
- Third party cash-receipting
- Procurement – public works projects
- Employee checking account

## RELATED REPORTS

### **Financial**

Our opinion on the District's financial statements and compliance with federal grant program requirements is provided in a separate report, which includes the District's financial statements.

### **Federal grant programs**

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the District's major federal programs, which are listed in the Federal Summary section of the financial statement and single audit report.

## INFORMATION ABOUT THE DISTRICT

Public Utility District No. 1 of Kitsap County provides an array of services including management of over 50 domestic water systems owned by the District. In addition, the District provides Satellite Management Agency services to over 120 other satellite water systems within Kitsap County. The District repairs water systems and provides education on water resource planning and conservation. In all, the District provides some level of domestic water service to over 50,000 Kitsap County residents. The District also provides countywide wholesale broadband infrastructure and works with retail service providers to provide state-of-the-art connectivity opportunities for residents.

An elected, three-member Board of Commissioners governs the District. The Board appoints a General Manager to oversee the District's daily operations as well as its approximately 44 employees. Its main sources of revenue include water usage fees, property taxes and wholesale telecommunications services. For fiscal year 2013, the District operated on annual revenue of approximately \$9.7 million.
