AUDIT SUMMARY

Results in brief

In most areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to the City management in a letter dated September 18, 2014 related to Municipal Courts' internal controls. We appreciate the City's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the City of Bainbridge Island from January 1, 2013 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cost allocation plan
- Municipal courts
- Procurement (bidding/prevailing wage)
- Credit cards
- Conflict of interest

RELATED REPORTS

Financial

Our opinion on the City's financial statements and compliance with federal grant program requirements is provided in a separate report, which includes the City's financial statements.

Federal grant programs

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the City's major federal program, which is listed in the Federal Summary section of the financial statement and single audit report. That report includes a federal finding regarding the City's internal controls, which were inadequate to ensure compliance with federal Davis-Bacon Act (prevailing wage) requirements for its Highway Planning and Construction Grant.

INFORMATION ABOUT THE CITY

The City of Bainbridge Island serves approximately 23,000 citizens in Kitsap County. The City provides an array of services including police, water, sewer and storm drainage, Municipal Court, street maintenance, parks and boat docks, community service programs, and planning and economic development. It contracts for fire and jail services.

The City is administered by a council-manager form of government with seven elected Council Members each serving a four-year term. The Council selects one of its members to serve as Mayor for a one-year term. The Council appoints management to oversee the City's daily operations as well as its approximately 133 employees. During fiscal year 2013, the City had approximately \$29.4 million in revenue.
