# **Audit Summary**

## ***ABOUT THE AUDIT***

This report contains the results of our independent accountability audit of Town of Conconully from January 1, 2013 through December 31, 2013.

The objective of our audit was to evaluate the adequacy of the Town's internal controls to safeguard public resources and the Town's compliance with state law and its own policies. In keeping with general auditing practices, we did not review every aspect of the Town's internal controls and compliance. Instead, our review focused on areas representing the highest risk of misappropriation, misuse or noncompliance.

Our report is addressed to the governing body and management of the Town. However, this report is a matter of public record and its distribution is not limited.

## ***RESULTS***

In the areas we examined, the Town's internal controls were adequate to safeguard public assets. The Town also complied with state laws and its own policies in the areas we examined.

The Town of Conconully has a population of approximately 210 residents in Okanogan County. The Town is governed by an elected, five-member Council and a separately elected Mayor. The Town has two employees and generated less than \$450,000 annually for 2013.
