### **Audit Summary**

### Kittitas County Weed District No. 4 October 7, 2014

#### **ABOUT THE AUDIT**

This report contains the results of our independent accountability audit of Kittitas County Weed District No. 4 from January 1, 2012 through December 31, 2013.

The objective of our audit was to evaluate the adequacy of the District's internal controls to safeguard public resources and the District's compliance with state law and its own policies. In keeping with general auditing practices, we did not review every aspect of the District's internal controls and compliance. Instead, our review focused on areas representing the highest risk of misappropriation, misuse or noncompliance.

Our report is addressed to the governing body and management of the District. However, this report is a matter of public record and its distribution is not limited.

#### RESULTS

In the areas we examined, the District's internal controls were adequate to safeguard public assets. The District also complied with state laws and its own policies in the areas we examined.

### **Description of the District**

#### ABOUT THE DISTRICT

Kittitas County Weed District No. 4, through an interlocal agreement with the Kittitas County Noxious Weed Control Board, provides noxious weed prevention and early intervention services for agricultural lands and natural resources near Ellensburg.

An elected, three-member Board of Directors governs the District. The District's annual revenue in 2012 and 2013, primarily composed of special assessments on property within the District boundaries, was approximately \$15,000 and \$24,000, respectively.
