Audit Summary

La Conner Regional Library Skagit County October 8, 2014

ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the La Conner Regional Library from January 1, 2011 through December 31, 2013.

The objective of our audit was to evaluate the adequacy of the District's internal controls to safeguard public resources and the District's compliance with state law and its own policies. In keeping with general auditing practices, we did not review every aspect of the District's internal controls and compliance. Instead, our review focused on areas representing the highest risk of misappropriation, misuse or noncompliance.

Our report is addressed to the governing body and management of the District. However, this report is a matter of public record and its distribution is not limited.

RESULTS

In the areas we examined, the District's internal controls were adequate to safeguard public assets. The District also complied with state laws and its own policies in the areas we examined.

However, we noted certain matters that we communicated to the District. We appreciate the District's commitment to resolving those matters.

Description of the District

ABOUT THE DISTRICT

The La Conner Regional Library District provides library services to approximately 4,700 residents in Skagit County. The District's boundaries include residents within the 36 square-mile La Conner School District area. In 1997 the District was the first to become a rural partial library district after legislation was passed and brought forth by the citizens in La Conner.

The District is governed by a five-member Board of Trustees, appointed by the Skagit County Commissioners. Property taxes supply the main source of revenue for the District with total receipts of approximately \$264,000 in 2011, \$275,000 in 2012 and \$306,500 in 2013.
