Audit Summary

Kittitas County Fire Protection District No. 8 October 6, 2014

ABOUT THE AUDIT

This report contains the results of our independent accountability audit of Kittitas County Fire Protection District No. 8 from January 1, 2010 through December 31, 2013.

The objective of our audit was to evaluate the adequacy of the District's internal controls to safeguard public resources and the District's compliance with state law and its own policies. In keeping with general auditing practices, we did not review every aspect of the District's internal controls and compliance. Instead, our review focused on areas representing the highest risk of misappropriation, misuse or noncompliance.

Our report is addressed to the governing body and management of the District. However, this report is a matter of public record and its distribution is not limited.

RESULTS

In the areas we examined, the District's internal controls were adequate to safeguard public assets. The District also complied with state laws and its own policies in the areas we examined.

However, we noted certain matters that we communicated to the District. We appreciate the District's commitment to resolving those matters.

Description of the District

ABOUT THE DISTRICT

Kittitas County Fire Protection District No. 8, formed in 1980, provides fire and emergency medical services to the Lake Kachess, Stampede Pass, Crystal Springs and Cabin Creek U-Fish areas along with a portion of I-90, as well as the Roaring Creek community near Easton. The District's service area covers approximately 20 square miles. It has approximately 23 volunteer firefighters, 11 of whom are emergency medical technicians and two are paramedics.

An elected, three-member Board of Commissioners governs the District. For the fiscal years ending December 31, 2010, 2011, 2012 and 2013, the District had operating revenues of approximately \$172,000, \$263,000, \$290,000 and \$227,000, respectively. Of those annual revenue amounts, approximately \$170,000 was from the collection of property taxes.
