### **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the City of Snohomish Transportation Benefit District from September 21, 2010 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

• Allowable use of funds

- Open Public Meetings Act
- Annual report submission compliance

### INFORMATION ABOUT THE DISTRICT

The City of Snohomish Transportation Benefit District, created in 2010, is an independent taxing district created for the sole purpose of funding transportation improvements within the city of Snohomish. The Snohomish City Council serves as the governing body of the District. Its primary revenue source is two-tenths of one percent local sales tax. The District had operating expenditures of approximately \$194,330 in 2012 and \$447,213 in 2013, the first two years the District collected and disbursed revenues.
