AUDIT SUMMARY

Results in brief

In the areas we audited, Program operations complied with applicable requirements and provided adequate safeguarding of public resources. The Program also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Capitol Hill Housing Improvement Program from January 1, 2013 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Program's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Billings/receivables
- Cash receipting

- Procurement (bidding/prevailing wage)
- Payroll/personnel

Financial

A financial statement audit was performed by a firm of certified public accountants. That firm's report is available from the Program.

Federal grant programs

A firm of certified public accountants evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the Program's major federal program. That firm's report is available from the Capitol Hill Housing Improvement Program.

INFORMATION ABOUT THE PROGRAM

The Capitol Hill Housing Improvement Program is a public development authority created by the city of Seattle. Public development authorities are public corporations created to perform a particular function, as allowed by state law (RCW 35.21.730-759), for the purpose of improving administration and efficiency. The city of Seattle created the Program in 1975 to assist residents and property owners in preserving and improving housing and neighborhoods.

The Program's 15-member Board of Directors is composed of three members appointed by the Mayor of the city of Seattle, at least seven members who live or own property in Capitol Hill, and one member who is a tenant of the Program's properties. All Board Members except the Mayoral appointees are approved by majority vote of the Board. Although the Mayor appoints three Board Members, the Program is not considered a city department or agency. Liabilities of the Program are not liabilities of the city.
