#### **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of Benton County Fire Protection District No. 2 from January 1, 2011 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open Public Meetings Act
- Interlocal agreements
- State grant

- Procurement for purchases
- Credit cards

#### INFORMATION ABOUT THE DISTRICT

Benton County Fire Protection District No. 2 was formed in 1949 to provide fire protection services to the citizens of Benton County. The District's service area covers Benton City and the surrounding areas. An elected, three-member Board of Commissioners governs the District.

The Board appoints a Fire Chief to oversee the District's daily operations as well as its three employees and several volunteers. The District received revenue of \$901,501 in 2011, \$1,242,461 in 2012, and \$1,260,405 in 2013. Approximately 70 percent of the District's revenue comes from property taxes.
