AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Marysville Fire District from January 1, 2012 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

• Payroll

- Third-party cash receipting
- Bidding and procurement requirements

INFORMATION ABOUT THE DISTRICT

The Marysville Fire District is a joint cooperative between Snohomish County Fire Protection District No. 12 and the city of Marysville. The District provides fire prevention, suppression and emergency medical services to a 54 square-mile area in Snohomish County. The District's service area includes the incorporated Marysville area, north toward Smokey Point, east toward Highway 9 and south along Sunnyside Boulevard in unincorporated Snohomish County. The District has operated under an interlocal agreement with the city of Marysville and Snohomish County Fire Protection District No. 12 since 1992.

A six-member Board of Directors governs District operations. The Board is made up of three elected City Council members and three Fire District No. 12 Commissioners. The Board appoints a Fire Chief to oversee the District's daily operations as well as its approximately 93 full-time and 30 part-time employees. The District's operating expenditures for fiscal years 2012 and 2013 were \$13,064,965 and \$13,965,969, respectively.
