## AUDIT SUMMARY

### Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the City of Sammamish from January 1, 2013 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash receipting – building permit
- Cash receipting – parks and recreation
- Procurement – public works project
- Personal service contracts
- Donations
- Procurement – professional services

## INFORMATION ABOUT THE CITY

The City of Sammamish, incorporated on August 31, 1999, serves approximately 49,260 residents in east King County. The City provides services including parks and recreation, police and fire protection, public works, permits, community and economic development and storm water maintenance.

An elected, seven-member Council administers the City. The Council selects one of its members to serve as Mayor. The Council appoints a City Manager to oversee the City's daily operations as well as its 72 full-time employees. For the 2013-2014 biennium, budgeted expenditures totaled approximately \$116.4 million.
