## AUDIT SUMMARY

### Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the City of Winlock from January 1, 2012 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open Public Meetings Act
- Financial condition
- General revenue and expenditures
- Cost allocation
- Third-party receipting
- Utility billing and receipting
- Payroll
- General disbursements
- Cash receipting

## INFORMATION ABOUT THE CITY

The City of Winlock serves approximately 1,340 citizens in Lewis County. The City provides a full range of services including police, street maintenance and construction, judicial and general administration services. In addition, the City owns and operates water, storm water and sewer systems.

The City is administered by a mayor-council form of government with an elected, five-member Council and an independently elected Mayor. The Mayor appoints management to oversee the City's daily operations as well as its nine employees. For fiscal years 2012 and 2013, the City's operating budget was \$3,662,700 and \$3,214,626, respectively.
