AUDIT SUMMARY

Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the City of Algona from January 1, 2011 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Billings/receivables
- Cash receipting
- Open public meeting minutes
- Citizen hotline referral

- Payments/expenditures
- Police property room
- Payroll/personnel

INFORMATION ABOUT THE CITY

The City of Algona, incorporated in 1955, is located in south King County between the cities of Auburn and Pacific, near the border of Pierce County. The City provides its 3,000 citizens with services including police, community and economic development, public works, water, and sewer and stormwater utilities.

An elected, five-member Council and an independently elected Mayor govern the City. The Council appoints management to oversee the City's daily operations as well as its approximately 20 employees. In 2011, 2012 and 2013, the City operated on budgets of approximately \$10.5 million, \$11 million and \$9 million, respectively.
