## AUDIT SUMMARY

### Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to the District management in a letter dated October 16, 2014, related to cash receipting. We appreciate the District's commitment to resolving those matters.

### About the audit

This report contains the results of our independent accountability audit of the Dallesport Water District from January 1, 2011 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Billings/receivables
- Open public meeting minutes
- Cash receipting

## INFORMATION ABOUT THE DISTRICT

The Dallesport Water District, formed in August 2009, provides water services to the Dallesport and Murdock communities in Klickitat County. An elected, three-member Board of Commissioners governs the District. At the District's December 8, 2010, meeting an agreement was signed transferring ownership of Murdock Water and Mountain View Water Associations to the District. The systems will be owned, managed and operated by the District as individual systems, with independent budgets, improvements and Small Water System Plans. The agreement not only allows the District to aid these systems in seeking water system and fire protection improvements, but also puts the District in a better position for receiving funding that could benefit the entire Dallesport/Murdock peninsula.

The District collected approximately \$168,000, \$259,000 and \$620,000 in revenues in 2011, 2012 and 2013, respectively.
