AUDIT SUMMARY

Results in brief

In the areas we audited, Authority operations complied with applicable requirements and provided adequate safeguarding of public resources. The Authority also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Valley Transit from January 1, 2011 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Authority's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Credit cards
- Payroll – retirement cash-out
- General disbursements
- Procurement – purchases
- Procurement – architectural and engineering services

INFORMATION ABOUT THE AUTHORITY

The Valley Transit was created in 1980 and is governed by an appointed, seven-member Board of Directors. The Authority operates on a \$4.5 million annual operating budget. The Authority's 48 employees provide public transportation services to approximately 56,000 citizens in the cities of Walla Walla and College Place and parts of incorporated Walla Walla County.
