## **Audit Summary**

## Port of Pasco Economic Development Corporation Franklin County October 6, 2014

#### ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the Port of Pasco Economic Development Corporation from January 1, 2013 through December 31, 2013.

The objective of our audit was to evaluate the adequacy of the Corporation's internal controls to safeguard public resources and the Corporation's compliance with state law and its own policies. In keeping with general auditing practices, we did not review every aspect of the Corporation's internal controls and compliance. Instead, our review focused on areas representing the highest risk of misappropriation, misuse or noncompliance.

Our report is addressed to the governing body and management of the Corporation. However, this report is a matter of public record and its distribution is not limited.

#### RESULTS

In the areas we examined, the Corporation's internal controls were adequate to safeguard public assets. The Corporation also complied with state laws and its own policies in the areas we examined.

However, we noted certain matters that we communicated to the Corporation. We appreciate the Corporation's commitment to resolving those matters.

#### **ABOUT THE CORPORATION**

The Port of Pasco Economic Development Corporation is overseen by an appointed Board of Directors with a Chairman, Vice Chairman, Secretary and Treasurer. The Corporation is a component unit of the Port of Pasco with annual revenue of \$2,000.

The Economic Development Corporation of the Port of Pasco allows for the issuance of Industrial Revenue Bonds for development of industrial lands, facilities, services and activities in the Port of Pasco. The revenue bonds provide tax-exempt interest to bond holders, which allow bonds to be issued at a lower rate of interest. The Corporation has established criteria for the issuance of industrial revenue bonds. It is the goal of the Port of Pasco to encourage and assist industrial development at the Port facilities.
