AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Columbia Basin Hospital from January 1, 2013 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Paroll payments
- Third party cash receipting

A financial statement audit was performed by a firm of certified public accountants. That firm's report is available from the Columbia Basin Hospital.

INFORMATION ABOUT THE DISTRICT

Grant County Public Hospital District No. 3 owns and operates Columbia Basin Hospital, a 25-bed acute care facility and 12-bed skilled nursing facility. The District also owns and operates Columbia Basin Family Medicine and Garden Oasis Assisted Living, a 32-unit assisted living facility. These facilities provide an array of services including acute care hospital, long-term nursing care, emergency room, physicians' clinic and related procedures (lab, X-ray and therapy) associated with those services to patients in the Ephrata area.

An elected, five-member Board of Commissioners governs the District. The Board appoints an Administrator to oversee the District's daily operations as well as its 121 full-time and 70 part-time employees. For fiscal year 2013, the District operated on an annual operating budget of approximately \$14 million.
