AUDIT SUMMARY

Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the City of Prosser from January 1, 2013 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Utility billings/receivables
- Contracts/agreements
- Gifts of public funds
- Procurement (bidding/change orders)
- Vendor payments
- Compliance with grant requirements
- Use of restricted funds
- Payroll seasonal employees

RELATED REPORTS

Financial

Our opinion on the City's financial statements and compliance with federal grant program requirements is provided in a separate report, which includes the City's financial statements.

Federal grant programs

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the City's major federal programs, which are listed in the Federal Summary section of the financial statement and single audit report. That report includes a federal finding regarding noncompliance with suspension and debarment requirements.

INFORMATION ABOUT THE CITY

The City of Prosser, located in Benton County, was incorporated in 1899 and currently serves 5,815 citizens. It provides services including water, sewer, police, parks and recreation, building and planning. The City contracts out for fire, garbage and library services.

An elected, seven-member Council and a separately elected Mayor govern the City. The Mayor oversees the City's daily operations as well as its approximately 47 full-time employees. For 2013, the City's total budget for all funds was \$27.1 million.
