AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Mid-Columbia Library from January 1, 2011 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

INFORMATION ABOUT THE DISTRICT

The Mid-Columbia Library is an intercounty library district, established in November 1948 to serve the rural areas of Benton and Franklin counties. Through contracts or annexation, the District serves the following cities and communities: Basin City, Benton City, Connell, Kahlotus, Kennewick, Merrill's Corner, Mesa, Othello, Pasco, Prosser, West Richland and West Pasco.

A seven-member Board of Trustees administers the District. Trustees are appointed to seven-year terms. The District has approximately 130 employees to carry out its business. The District's major source of revenue comes from taxes levied on property in the unincorporated areas of Benton and Franklin counties as well as library services fees. For 2011, 2012 and 2013, the District operated on annual budgets of approximately \$6.7 million, \$7.4 million and \$7.4 million, respectively.
