# **Audit Summary**

## **Okanogan County Water Conservancy Board October 17, 2014**

### ***ABOUT THE AUDIT***

This report contains the results of our independent accountability audit of the Okanogan County Water Conservancy Board from January 1, 2011 through December 31, 2013.

The objective of our audit was to evaluate the adequacy of the Board's internal controls to safeguard public resources and the Board's compliance with state law and its own policies. In keeping with general auditing practices, we did not review every aspect of the Board's internal controls and compliance. Instead, our review focused on areas representing the highest risk of misappropriation, misuse or noncompliance.

Our report is addressed to the governing body and management of the Board. However, this report is a matter of public record and its distribution is not limited.

### ***RESULTS***

In the areas we examined, the Board's internal controls were adequate to safeguard public assets. The Board also complied with state laws and its own policies in the areas we examined.

However, we noted certain matters that we communicated to the Board. We appreciate the Board's commitment to resolving those matters.

The Okanogan County Water Conservancy Board was established in 2000 to provide local processing of water right transfer applications and records of decision for Okanogan County.
