Audit Summary

ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the Ellensburg Business Development Authority from January 1, 2011 through December 31, 2013.

The objective of our audit was to evaluate the adequacy of the Authority's internal controls to safeguard public resources and the Authority's compliance with state law and its own policies. In keeping with general auditing practices, we did not review every aspect of the Authority's internal controls and compliance. Instead, our review focused on areas representing the highest risk of misappropriation, misuse or noncompliance.

Our report is addressed to the governing body and management of the Authority. However, this report is a matter of public record and its distribution is not limited.

RESULTS

In the areas we examined, the Authority's internal controls were adequate to safeguard public assets. The Authority also complied with state laws and its own policies in the areas we examined.

However, we noted certain matters that we communicated to the Authority. We appreciate the Authority's commitment to resolving those matters.

ABOUT THE AUTHORITY

The Ellensburg Business Development Authority was established in 1994 to create and retain full-time employment opportunities for citizens of Ellensburg and Kittitas County by emphasizing the establishment of light industrial companies. In addition, the Authority provides business management, financial, expansion and other assistance, as well as provides access to shared centralized services. The Authority's two buildings are temporary homes for businesses that are just starting out.

An elected, nine-member Board of Directors governs the Authority. For fiscal years 2011, 2012 and 2013, the Authority generated average revenues of \$241,000 per year and incurred average expenditures of \$194,000.
