AUDIT SUMMARY

Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the City of Oak Harbor from January 1, 2013 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Contracts and agreements
- Change orders
- Police Department review
- Third party cash receipting

- Development Services Department review
- Software system security review
- Credit card expenditures

INFORMATION ABOUT THE CITY

The City of Oak Harbor is located in Island County and has a population of approximately 22,200 citizens. It provides an array of services including police, fire, water, sewer, solid waste, street maintenance, planning, parks and marina operations. The City also provides water to the Whidbey Island Naval Air Station.

An elected, seven-member Council and a separately elected Mayor governs the City and appoints management to oversee the City's daily operations and its approximately 145 employees. The City incurred total expenditures of approximately \$30.2 million in fiscal year 2013.
