## **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of Whatcom County Fire Protection District No. 7 from January 1, 2012 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open Public Meetings Act
- Credit cards/travel expenditures
- Payroll
- Emergency medical services billings

## INFORMATION ABOUT THE DISTRICT

Whatcom County Fire Protection District No. 7 provides fire prevention and suppression and ambulance services to approximately 23,000 Whatcom County residents. The District's service area covers 75 square miles and includes the city of Ferndale by a contractual agreement.

An elected, three-member Board of Commissioners governs the District. The Board appoints a fire chief to oversee the District's daily operations as well as its 43 employees and 60 volunteers. For fiscal years 2012 and 2013, the District operated on budgets of approximately \$4.7 million and \$4.9 million, respectively.
