## AUDIT SUMMARY

### Results in brief

In most areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to the City management in a letter dated October 15, 2014 related to golf course operations. We appreciate the City's commitment to resolving those matters.

### About the audit

This report contains the results of our independent accountability audit of the City of Chelan from January 1, 2013 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Golf course operations

Our opinion on the City's financial statements and compliance with federal grant program requirements is provided in a separate report, which includes the City's financial statements.

### **Federal grant programs**

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the City's major federal program, which is listed in the Federal Summary section of the financial statement and single audit report. That report includes a federal finding regarding suspension and debarment.

## INFORMATION ABOUT THE CITY

The City of Chelan serves over 4,000 citizens in Chelan County. The City provides an array of services including water, sewer, garbage, parks and recreation and planning. The City also operates an RV park, marina, an 18-hole golf course and a professional putting course.

An elected, seven-member Council and an independently elected Mayor govern the City. The Mayor hires an Administrator to oversee the City's daily operations as well as its 47 employees and up to 70 additional seasonal employees. For fiscal year 2013, the City had an annual operating budget of approximately \$18.7 million.
