AUDIT SUMMARY

Results in brief

In the areas we audited, Agency operations complied with applicable requirements and provided adequate safeguarding of public resources. The Agency also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Multi Agency Communications Center from January 1, 2012 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Agency's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

• Release of project retainage fees

INFORMATION ABOUT THE AGENCY

The Multi Agency Communications Center was formed through an interlocal agreement in January 1995. Thirty-seven public agencies, municipalities and districts created the consolidated public safety 9-1-1 dispatch center for law, fire and emergency medical aid.

An appointed, seven-member Board of Directors governs the Agency. Board Members are appointed by the entities and associations that they represent. The Board appoints a Director to oversee the Agency's daily operations as well as its 25 employees. For the 2012 and 2013 fiscal years, the Agency had approximate operating expenses of \$2.5 million and \$2.6 million, respectively.
