AUDIT SUMMARY

Results in brief

In the areas we audited, Port operations complied with applicable requirements and provided adequate safeguarding of public resources. The Port also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Port of Moses Lake from January 1, 2013 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Port's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

• Disbursements

• Cash receipting – customs office

Our opinion on the Port's financial statements and compliance with federal grant program requirements is provided in a separate report, which includes the Port's financial statements.

Federal grant programs

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the Port's major federal program, which is listed in the Federal Summary section of the financial statement and single audit report.

INFORMATION ABOUT THE PORT

Grant County Port District No. 10, doing business as the Port of Moses Lake, was established in 1966 and is located in Grant County. The Port covers approximately 5,000 acres and offers one million square feet of rental space. The Port operates an airfield with four runways and an industrial park. In addition, the Port provides aircraft fire-fighter training.

An elected, three-member Board of Commissioners governs the Port. The Board appoints management to oversee the Port's daily operations as well as its 16 employees. For fiscal year 2013, the Port operated on an annual budget of approximately \$6.2 million.
