## AUDIT SUMMARY

### Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the City of Aberdeen from January 1, 2012 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open public meetings
- General revenue/expenditures
- Financial condition and interfund transactions
- Equipment rental and reserve funds
- Procurement
- Key system controls
- Third-party cash receipting
- Utility adjustments/cash receipting
- Cost allocation
- Parks and Recreation Department
- Ambulance billings

## INFORMATION ABOUT THE CITY

The City of Aberdeen serves 16,470 citizens in Grays Harbor County. The City provides services including public safety, fire protection, Municipal Court, utilities, streets, parks and recreation, planning and zoning and general administrative services. The City is also one of three entities participating in the Grays Harbor County Drug Task Force.

A mayor-council form of government governs the City with an elected, 12-member Council and an independently elected Mayor. The Council appoints management to oversee the City's daily operations as well as its 171.2 employees. For fiscal years 2012 and 2013, the City operated on an annual general fund budgets of \$17.4 million and \$17.1 million, respectively.
