## AUDIT SUMMARY

### Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the City of Zillah from January 1, 2011 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Safeguarding of small and attractive assets such as computers
- Disbursements
- Open public meeting minutes
- Cost allocation plans
- Procurement (bidding)
- Budget compliance

## INFORMATION ABOUT THE CITY

The City of Zillah serves approximately 3,000 citizens in Yakima County. It is a noncharter-code city administered by a mayor-council form of government. The citizens elect five Council members and a Mayor. The City operates on a \$6 million budget. Its 25 full-time and three seasonal employees provide services including water, sewer, irrigation, police and Municipal Court. The City also operates a cemetery, a seasonal swimming pool and has a full-time Fire Chief, volunteer fire department, and contracts with a private contractor for garbage service.
