## AUDIT SUMMARY

### Results in brief

In the areas we audited, Agency operations complied with applicable requirements and provided adequate safeguarding of public resources. The Agency also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the Puget Sound Partnership from July 1, 2012 through June 30, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Agency's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Payroll
- Expenditures, vouchers and credit cards
- Purchase of goods and services
- Competitive bidding contracts

## RELATED REPORTS

### **Financial**

We perform an annual audit of the statewide basic financial statements, as required by state law (RCW 43.09.310). Our opinion on these financial statements is included in the Comprehensive Annual Financial Report (CAFR) prepared by and available from the Office of Financial Management.

The CAFR reflects the financial activities of all funds, organizations, institutions, agencies, departments and offices that are part of the state's reporting entity. ### **Federal programs**

In accordance with the Single Audit Act, we annually audit major federal programs administered by the state of Washington. Rather than perform a single audit of each agency, we audit the state as a whole. The results of that audit are published in a report issued by the Office of Financial Management in March of each year.

## INFORMATION ABOUT THE AGENCY

The Puget Sound Partnership, established on July 1, 2007, is the state agency mobilizing the collective initiative to restore and protect Puget Sound. The law that created the Agency states:

Leadership, accountability, government transparency, thoughtful and responsible spending of public funds and public involvement will be integral to the success of efforts to restore and protect the Puget Sound (RCW 90.71.200 (d)).

To fulfill that charter, the Agency works with more than 750 cross-sector partners (federal, state, tribal and local governments along with nonprofit organizations and private businesses) to guide smart investments that accelerate the rate of recovery, catalyze and coordinate activities in alignment with the Action Agenda (the region's roadmap for Puget Sound recovery) and establish and support shared measurement practices. The Governor-appointed Leadership Council, as well as the Ecosystem Coordination Board and Puget Sound Science Panel, advise and inform the Agency's strategic and programmatic efforts to advance Puget Sound recovery.
