### **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the Covington Water District from January 1, 2013 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

## INFORMATION ABOUT THE DISTRICT

The Covington Water District was created in 1960 and until 1988 was known as King County Water District No. 105. Geographical boundaries of the District's service area, approximately 53 square miles, were established to accommodate the zoning and growth permitted by the cities of Covington, Maple Valley and Black Diamond, as well as unincorporated King County. The District has over 17,000 connections, of which over 97 percent are residential. The District has 11 production wells at four sites, eight tanks at seven sites and two treatment plant facilities.

The District is a partner in the Regional Water Second Supply project with the cities of Tacoma and Kent and Lakehaven Utility District, which provides the participants with additional water supply on a long-term basis. The District has approximately \$10 million in annual operating expenses and 41 full- and part-time employees. An elected, five-member Board of Commissioners oversees the District.
