AUDIT SUMMARY

Results in brief

In the areas we audited, Port operations complied with applicable requirements and provided adequate safeguarding of public resources. The Port also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Port of South Whidbey Island from January 1, 2011 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Port's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Leases
- Procurement and public works projects
- Payroll

- Cash receipting
- Open Public Meetings Act

INFORMATION ABOUT THE PORT

The Port of South Whidbey Island, located in Island County, was incorporated in 1964 as the Port of Langley. The name was changed in 1980. The Port had revenues of approximately \$700,000, \$1,500,000 and \$2,300,000 for the years 2011, 2012 and 2013, respectively. The Port has five full-time employees along with occasional or seasonal assistance throughout the year. The Port operates under the laws of the state of Washington applicable to port districts under Title 53 RCW. An elected, three-member Board of Commissioners governs the Port. Each Commissioner serves a six-year term.
