## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of King County Fire Protection District No. 34 from January 1, 2012 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Payroll disbursement
- Payments/expenditures
- Controls over credit card use

## INFORMATION ABOUT THE DISTRICT

King County Fire Protection District No. 34 was formed in 1948 and serves approximately 22,500 residents in a 28 square-mile service area east of the Redmond city limits. The District contracts with the City of Redmond to staff four stations located throughout the District. The City of Redmond also maintains three stations within its jurisdiction. The operation is known as the Redmond Fire Department.

An elected, three-member Board of Commissioners governs the District. The Board oversees the District's daily operations with one employee. For 2012 and 2013, the District operated on annual budgets of approximately \$5.9 million.
