#### AUDIT SUMMARY

#### **Results in brief**

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the South Pend Oreille Fire and Rescue from January 1, 2011 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement (bidding/prevailing wage)
- Open public meeting minutes

- Use of credit cards
- Gifts of public funds

• Surplus property

#### **INFORMATION ABOUT THE DISTRICT**

Pend Oreille County Fire Protection District No. 3, doing business as South Pend Oreille Fire and Rescue, was incorporated in 1972 and provides fire protection and basic life support services to approximately 3,000 residents in Pend Oreille County. In 2009 the District merged with Pend Oreille County Fire Protection Districts No. 1 and No. 7.

An elected, five-member Board of Commissioners governs the District. The Board appoints a Chief who is responsible for the day-to-day operations as well as its two other employees and approximately 50 volunteers. The District is funded primarily through property taxes. For fiscal years 2011, 2012 and 2013, the District operated on annual budgets of approximately \$500,000.
