AUDIT SUMMARY

Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in most areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated November 17, 2014 related to procurement requirements for utilizing the small works roster and architect and engineering services. We appreciate the District's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of Benton County Fire Protection District No. 4 from January 1, 2011 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement public works
- Procurement architectural and engineering services
- Procurement equipment purchases
- Credit card purchases
- General obligation bond proceeds, allowable costs

INFORMATION ABOUT THE DISTRICT

Benton County Fire Protection District No. 4 was formed in 1953 to provide fire protection and fire suppression services for citizens of central east Benton County. The service area covers approximately 52 square miles between the cities of Richland and Benton City.

The District is overseen by an elected, five-member Board of Commissioners. The Board appoints a Fire Chief to oversee the District's daily operations as well as its three employees and several volunteers. The District received revenue of approximately \$2,227,642 in 2011, \$2,266,755 in 2012 and \$2,395,642 in 2013. Benton County serves as the treasurer for the District.
