AUDIT SUMMARY

Results in brief

In the areas we audited, Housing Authority operations complied with applicable requirements and provided adequate safeguarding of public resources. The Housing Authority also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Anacortes Housing Authority from April 1, 2012 through March 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Housing Authority's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open Public Meetings Act
- Financial condition
- Credit card controls

- Payroll leave balances
- Cash receipting
- Tenant eligibility

INFORMATION ABOUT THE HOUSING AUTHORITY

The Anacortes Housing Authority was established in 1968 to provide and manage housing for low-income residents of the city of Anacortes, located in Skagit County. The Housing Authority currently owns and operates 112 public housing units. The Housing Authority's primary funding sources are rental revenue and federal grant subsidies.

The Mayor of Anacortes appoints a five-member Board of Commissioners to govern the Housing Authority. Daily operations are overseen by eight full-time employees. During fiscal year 2014, the Housing Authority had revenues of \$721,413 and expenses of \$1,011,533. The Housing Authority also acts as the general partner for the Tax Credit Partnership, AHA-Bayview Apartments Limited Partnership (46 low-income units with some Section 8 project-based assistance) and the managing member for the Tax Credit Partnership, the Wilson Hotel Housing, LLC (25 units).
