AUDIT SUMMARY

Results in brief

In most areas we audited, Port operations complied with applicable requirements and provided adequate safeguarding of public resources. The Port also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to the Port management in a letter dated November 4, 2014 related to leasing activity. We appreciate the Port's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the Port of Woodland from January 1, 2011 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Port's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

• Leasing activities

- Disbursements
- Open public meeting minutes

INFORMATION ABOUT THE PORT

The Port of Woodland, located in Cowlitz County, was formed in 1961. The Port has two industrial parks occupied by 22 tenants that lease land or building space. Additional assets include a future 20-acre light industrial park and approximately 200 acres of undeveloped waterfront property.

An elected, three-member Board of Commissioners governs the Port and appoints an Executive Director to oversee the daily business and the Port's three employees. Tax receipts and lease revenues are the primary sources of the Port's revenue. The Port's annual revenue is approximately \$1.2 million.
