AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Willapa Valley Water District from January 1, 2011 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open Public Meetings Act
- Financial condition
- General revenue and expenditures
- Utility billing
- Cash receipting
- Key system controls

INFORMATION ABOUT THE DISTRICT

The Willapa Valley Water District succeeded the Willapa Valley Water Company, a private corporation, in 1934, in order to be eligible to receive state funding to finance expansion. The District provides water service to approximately 730 customers in the Willapa Valley area of Pacific County.

An elected, three-member Board of Commissioners governs the District and oversees the District's three employees. The District operated on budgets of \$411,500 in 2011, \$415,900 in 2012 and \$400,100 in 2013.
