AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Mason County Fire Protection District No. 3 from January 1, 2012 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- General disbursements
- Petty cash and imprest funds
- Procurement purchasing
- Financial statement funds

- Social Security payback
- Grapeview Community Association agreement follow up

INFORMATION ABOUT THE DISTRICT

Mason County Fire Protection District No. 3 was formed in 1949 to provide fire protection and emergency medical services to residents of Grapeview and the surrounding areas.

An elected, three-member Board of Commissioners governs the District. The District appoints a Fire Chief to oversee the District's daily operations as well as its six part-time employees and approximately 22 volunteers. The District operated on annual budgets of approximately \$435,000 in 2012 and approximately \$443,000 in 2013.
