AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Penn Cove Water and Sewer District from January 1, 2011 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- District employees as commissioners
- Employee appreciation dinners
- Leave buybacks

INFORMATION ABOUT THE DISTRICT

The Penn Cove Water and Sewer District provides water and sewer service to Island County residents. Located approximately two miles south of Oak Harbor, the District provides water to approximately 260 residences and sewer service to approximately 250 residences.

An elected, three-member Board of Commissioners governs the District. A Board-appointed District Manager supervises overall operations as well as four part-time employees. The operating budgets were approximately \$288,000 for 2011, \$352,000 for 2012 and \$328,000 for 2013.
